

Entry Procedures & Rules

1. This art exhibit is non-juried, open to all artists residing in Butler County or using Butler County landmarks/locations as the theme for their work. This exhibit will run concurrently with the "Sunnyview Visual Stimulation Art Project", which has a separate entry form and regulations for artwork competing to be selected for permanent display at Sunnyview's Memory Care Unit - please complete the appropriate entry form based on which exhibit/competition you wish to enter!
2. All artwork must be original, contain no copyright infringements, and ready to hang with wire or firmly affixed sawtooth hanger. Artwork not professionally framed will not be accepted, except for unframed canvases with wire hangers. No artwork displayed at The Art Center within the past two years will be accepted, and art must remain on display until the end of the exhibit.
3. **Art entries may be dropped off any time before Saturday, October 9, during normal business hours** (Wednesdays through Saturdays between the hours of noon and 4 PM). Art entry forms, payment, and gallery I.D. labels must also be received on or before the drop-off date.
4. Art entry fee is \$15.00 per piece. **AABC members will receive a \$5.00 discount on the initial entry fee.** If paying by check, make payable to "AABC" and please note the name of the exhibit on the check memo line.
5. Media categories are:
 - (a) Paintings (Oil, Watercolor, and Acrylics)
 - (b) Drawings (Pencil, Pen & Ink, Pastels, and Charcoal)
 - (c) 3D Sculpture, including fiber art, ceramics, and other sculpted materials
 - (d) Photography

- Items submitted as "Mixed Media" will be assigned to one of the above categories by the judge.
6. **Cash awards will be as follows:**
 - \$ 500 - Best of Show
 - \$ 100 - 1st Place in each category
 - \$ 100 - Judge's ChoiceRibbons will be provided to 2nd, 3rd, and Honorable Mention winners in each category.
 7. The AABC retains a 40% commission on art sales by non-Members and 30% for Members.
 8. **Artwork must be picked up on Saturday, Nov. 20.** Care will be taken in handling all artwork, but the AABC does not accept liability for lost or damaged artwork.
 9. The AABC retains the right to use photographs of entries in promotional materials.
 10. Artists, friends and family are invited to a catered, black tie optional "Meet the Artists" reception on Friday, Oct. 22, 7 - 9 PM, when the winners will be announced. Admission price is \$35 per person including catered refreshments and a cash wine/beer bar.
